Meeting Gwinnett County Public Schools' Facility and Technology Needs



Pictured above is the new Discovery High School, which opens in August of 2015. The school anchors the new Discovery Cluster, and provides relief primarily for Berkmar High School and Central Gwinnett High School. In addition to housing the high school, the facility also will be home to the new Junior Achievement Discovery Center at Gwinnett which will provide financial literacy lessons to 6th and 8th graders.

Since 1997, the Gwinnett special purpose local option sales tax for education (E-SPLOST) has provided thousands of classrooms and major technology improvements. Gwinnett voters extended the one-penny E-SPLOST in 2001 and 2006 by wide margins. In November of 2011, Gwinnett voters approved another extension which we refer to as SPLOST. Thanks to the original E-SPLOST and the three renewals, GCPS has been able to manage the challenges of dramatic growth in student enrollment, rather than being managed by it. (The school district's student enrollment continues to grow. In 2015, GCPS projects enrollment will surpass the 176,000 mark, growing by approximately 3,000 students over the 2014-15 enrollment.)

The current E-SPLOST (2012-2017) includes the following:

- New schools as well as additions and renovations at schools.
- Air conditioning for all middle and high school gyms and all elementary school activity buildings, along with all kitchens that currently do not have air conditioning.
- Significant technology upgrades for all schools and infrastructure support and digital content to support teaching and learning.
- Other facility improvements and preventive maintenance postponed due to budget cuts (roofing, painting, carpeting, etc.).

In 2008, Gwinnett voters also approved general obligation (GO) bonds to support the school system's building and technology plans. In addition to using funding from the current E-SPLOST, the district's long-range plan for meeting facility and technology needs—called The Plan—calls for several projects to be built and funded with GO bonds. eCLASS: Technology enhancements have a positive impact on every school and every child

In addition to facilities, the e-SPLOST extension is addressing technology projects, including the district's eCLASS initiative—our digital content, learning, assessment, and support system. Below are some highlights of our eCLASS progress to date, along with technology improvements that have been made systemwide to support teaching and learning:

- Schools throughout the district are participating in BYOD (Bring Your Own Device)
 to supplement students' access to web-based instructional resources during the
 school day, using the district's safe, filtered access to the Internet. Use of studentowned devices for learning is becoming a regular part of the classroom experience.
- The **Curriculum and Instruction Tool** was made available to all teachers and all classes in the Fall of 2014, after piloting in select classrooms and schools during the 2013–14 school year. The tool gives teachers and students **online course pages** where they can post and interact with digital materials, websites, closed discussion forums, and other online resources. Another feature allows students to submit work electronically and keep personal files in their "electronic lockers."
- Through the MyeCLASS Student Portal, students have easy access to digital textbooks, their online library, and other online materials tied directly to their classroom lessons.
 They also can keep track of their course grades and grades on individual assignments.
- In addition to an **electronic gradebook**, teachers have access to a broad range of data they can use to support students and their learning.
- Teachers also have access to online collaboration communities, where they can share
 with other teachers across the district. Online communication centers house instructional
 calendars, model lesson plans, and other curriculum resources. And, Gwinnett educators also have a growing library of videos that model the best ways to teach critical
 concepts and skills.
- The Professional Development and Evaluation Tool— launched in 2013— helps teachers get the support they need and provides key information about teacher evaluations, resources that improve instruction and, ultimately, student learning.
- The district has updated the technology in all Gwinnett middle schools and currently is updating the technology for all elementary schools. To date, 52 elementary schools have benefited from these technology improvements and the others will be completed by mid-January of 2016. These updates include new computers for the labs, a wireless infrastructure upgrade to support local school BYOD initiatives, and laptops for teachers and administrators. Student laptops and project carts also were part of this technology refreshment project, giving teachers and students resources to support collaborative learning on class projects and assignments. What other "new" technology is found in the updated or "retrofitted" classrooms? They include document cameras and new ceiling-mounted, high-definition (HD) projectors, and each school received a portable voice conference system that can be used in any teacher's classroom for electronic field trips and distance-learning initiatives.
- The e-SPLOST is funding a **new student information system**. The first phase of this multi-phase transition provided online registration capabilities for the new school year to many Gwinnett parents.
- By December of 2015, GCPS will have completed another project under the current e-SPLOST— the installation of new video camera systems to enhance security in the school common areas in all schools.
- The district also has partnered with the County to make security upgrades on school campuses. In addition, the county SPLOST is providing emergency-response buttons in all schools and a new visitor management system for all elementary schools.

Technology will permeate the education of Gwinnett's learners. Digital tools will expand the walls of the classroom, fostering collaboration and nurturing creativity and innovation in students and teachers. Appropriate technological tools and resources that are part of students' everyday, media-rich lives will be incorporated into the school day, making learning real and relevant to a student population that has never known a world without sophisticated technology. The district will provide a robust online environment to meet the evolving needs of students and staff and will promote safe, responsible use of technology. Employees will have the technology-based knowledge, skills, training, and tools they need to be effective in their jobs. Innovative technology will facilitate teaching and learning, enhance communication, strengthen the link between school and home, and ensure operational and analytical excellence in the day-to-day operations of the school system.

The school district will be a responsible steward of taxpayers' money while providing the necessary resources to support world-class teaching and learning. We will continue to manage our financial resources through a transparent management system that meets or exceeds the highest standards in accounting and financial reporting. As a result, confidence will be high among citizens, financial institutions, and the agencies that regulate the district's fiscal operations. Budget decisions will be made with a long-term perspective to ensure the district has adequate funds to meet both current and future needs. We will wisely use our limited financial resources while also pursuing additional sources of revenue. The school system will employ proven business practices and procedures at all times to ensure it meets the public's highest standards for accountability, integrity, and trust.

Favorable bond rating reflects GCPS' fiscal accountability, saves tax dollars

Gwinnett citizens have consistently supported critical school funding initiatives, including multiple bond and sales tax referenda. The taxpayers' trust in the school system has been well-placed, based on findings from external audits of GCPS' building programs. In recent audits, MGT of America commended GCPS on the management of its construction program. MGT found GCPS in full compliance in all areas audited, noting that the school system effectively has met its e-SPLOST objectives. GCPS also was commended for implementing processes that resulted in lower construction costs than those in neighboring counties.

In addition, GCPS recently received good news regarding its bond rating. Much like homeowners might refinance a house when a lower interest rate is offered, so has GCPS taken advantage of its favorable bond rating to refinance \$255 million of its outstanding general obligation (GO) bonds, generating a savings to the district of \$21.5 million. These savings will go directly back into the current e-SPLOST building program, providing the funding equivalent to one new elementary school.

As part of the refinancing process, the school district's

bond ratings were reaffirmed at the highest level (Aaa) with a stable outlook by both Standard & Poor's (S&P) and Moody's Investors Services. GCPS is the only school district in Georgia and in the Southeastern region of the nation that has attained a "Aaa" bond rating from Moody's and S&P. Only 13 school districts nationwide have earned this fiscal stamp of approval from both bond rating agencies.

GCPS' favorable bond ratings are based on the school district's strong financial management, which has allowed the district to maintain a good financial position despite ongoing growth and budget challenges; and low debt burden, in large part due to the district's ability to fund its ongoing capital needs through the e-SPLOST.

Gwinnett County Board of Education processes that increase communication about the building program, and that provide transparency and ensure projects are completed on time and within budget include the following:

- A master project list guides the work in delivering what was promised.
- A fair and open bidding process is used for all projects. A standard "design, bid, build" methodology is used by the Facilities and Operations Division to ensure all projects are awarded to the lowest, qualified bidder at a cost-per-square-foot that is consistently below market averages.
- Board action is required to approve bids on projects. Meeting agendas are posted
 each month prior to the Board's business meeting for citizens interested in updates
 on the SPLOST construction program. The construction report outlines each project,
 contractor, contract amount, change-order information, as well as any adjustments
 and comments regarding the projects.
- The School Board approves land purchases at Board meetings.
- A **financial report**, including e-SPLOST revenue collections, is part of each monthly School Board meeting.
- Updates regarding The Plan are posted on the district's website.
